1. A 4 / 2 week Special Course on "Automatic Train Protection System – Kavach" scheduled from 17.01.2022 notified to all concerned vide letter under reference, is now proposed to be held in **Hybrid mode**, consisting of Online Theory sessions and On-Campus Practical sessions instead of exclusive on-campus sessions, owing to sharp increase in number of Covid-19 positive cases.
